

Preface

One of the major challenges for doctors and nurses working in emergency medicine is the breadth of diseases and injuries they encounter. These range from treating eye conditions that may threaten a patient's sight, to severe infections that threaten life. They include recognising and initiating emergency treatment for the severely dehydrated, vomiting adolescent from, as yet undiagnosed type 1 diabetes, the patient with a blocked blood vessel that may lead to loss of a leg, a stroke or a heart attack, the patient whose depression has caused them to try to end their life and the woman who presents with life threatening bleeding from a miscarriage or ectopic pregnancy.

The list of potential emergency presentations is almost limitless and includes severe asthma, airway obstruction, anaphylaxis, life-threatening nose-bleeds, dislocated joints and fractures, bowel obstruction or perforation, severe trauma and burns and patients whose hearts beat dangerously fast or too slow threatening blood flow to the brain.

While the scope of emergencies is wide, the other major challenge is that countless life-threatening diseases and injuries are very uncommon; some so rare that they may be encountered only once or twice in a clinician's career.

How can a doctor or nurse retain the knowledge to recognise and manage the large number of conditions they encounter and even more importantly, how can they keep up to date with advances in their diagnosis and management? This is where this bedside guide becomes so valuable.

This handbook is an essential resource to clinicians working in emergency, to assist them to recognise and treat patients presenting with serious diseases and injuries. It incorporates detailed summaries of the latest research and guidelines for the management of medical emergencies, written specifically to provide immediate support and guidance.
